## From the Chair...

LABWSE would like to offer a warm welcome to our newest board members: Robert Showers, Peggy Salley, Yolanda Burnom, and Paulette Walker. Working diligently on behalf of the profession, the board's ultimate goal is to protect the public. Appointments to the board are for a period of three years, so the board changes somewhat with each new addition.

Your current board members are completely committed to thoughtfully considering all issues before them. At a frequency of about once every five weeks, the board meets in Baton Rouge on Friday beginning at 8:30 am. Accordingly, some board members travel from as far as Shreveport, which necessitates a two night stay in Baton Rouge. At times the business of the board requires the meeting to extend into the next day, Saturday.

We now have a new telephone answering system. The telephone system allows callers to leave a message for a specific staff member, if the staff member is not available to answer at the time of the call. We will also be seeking proposals for a new website and database design. The goal is to have more automated processes similar to the online renewal.

The Association of Social Work Boards is participating on an International Technology Task Force to develop new standards for the use of technology in social work practice. We would like to take this opportunity to remind practitioners that it is not acceptable to post any information, no matter how vague, regarding any of their clients on Facebook or any other social media forum.

Carmen Weisner, Executive Director of NASW-LA Chapter, reported to the board at our last meeting, that its executive committee had recently met and voiced concerns over the number of individuals practicing social work without a license. In addition, they are concerned about credentialed social workers practicing beyond their scope of practice. In response to these concerns, we

### Social Work: Who Must Be Licensed and What is Their Scope?

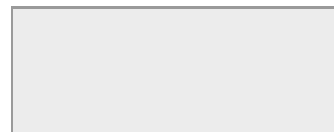
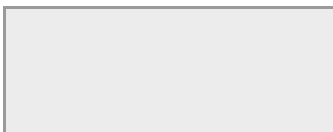
Individuals with an undergraduate or graduate degree in social work must be credentialed by LABSWE to practice social work in Louisiana. Practicing social work does not mean that your job title is social worker. The practice of social work is defined as the “professional application of social work values, theories, and interventions to one or more of the following: enhancing the development, problem-solving, and coping capacities of people; promoting the effective and humane operations of systems that provide resources and services to people; linking people with systems that provide them with resources, services, and opportunities; developing and improving social policy; and engaging in research related to the professional activities. The practice of social work shall include but not be limited to clinical social work, planning and community organization, policy and administration, research, and social work education. Social work practice is guided by knowledge of human behavior, biopsychosocial development, social systems and resources, economic and cultural institutions, and their interactions.” It is a common misconception that if the employer does not require licensure, then one does not need to be licensed. Any person with a degree in social work that is providing social work services as defined must be credentialed.
