## CONSENT AGREEMENT AND ORDER

WHEREAS, Jasmine Nelson ("Ms. Nelson") is a credentialed social worker subject to the jurisdiction and the rules and regulations of the Louisiana State Board of Social Work Examiners ("Board" or "LABSWE");

WHEREAS, on September 23, 2021, the Board initiated a complaint against Ms. Nelson based upon information obtained from a criminal background check associated with a LCSW application submitted by Ms. Nelson. Therein it was alleged that Ms. Nelson was arrested on October 30, 2019, for Second Degree Battery (felony) and Criminal Mischief (misdemeanor). Further, Ms. Nelson failed to disclose the arrest on her 2020 renewal application and her 2021 licensure application.

WHEREAS, by letter dated September 23, 2021, the Board notified Ms. Nelson of the complaint filed against her, provided Ms. Nelson with a summary of the nature of the complaint, and requested that Ms. Nelson provide a response to the complaint, including the disposition of the charges against her;

**WHEREAS**, by correspondence dated October 17, 2021, Ms. Nelson responded to the complaint, giving her response to the allegations contained therein;

WHEREAS, an informal conference (Bertucci hearing) was held on May 25, 2023, in this matter, during which Ms. Nelson, through counsel, presented her side of the case, and disclosed

that she intended to plead guilty to the Second Degree Battery charge, a felony. However, it was further indicated that the charge will be undesignated as a crime of violence and that once she completes the terms of probation, she will be able to get the charges removed from her record.

WHEREAS, pursuant to a complaint and an administrative investigation, Ms. Nelson has indicated her desire to resolve this matter through a Consent Agreement and Order as provided for in Rule No. 907 of the Board's Rules, Standards and Procedures and La. R.S. 49:975(D) of the Louisiana Administrative Procedure Act;

WHEREAS, Ms. Nelson has admitted to the following:

- 1. Ms. Nelson is a Licensed Master Social Worker ("LMSW") licensed by the Board to engage in the practice of social work in the State of Louisiana pursuant to the Social Work Practice Act, La. R.S. 37:2701 et. seq., as evidenced by License Number 13208.
- 2. Complainant is the Board.
- 3. Ms. Nelson was arrested for 2<sup>nd</sup> degree battery (La. R.S. 14:34.1) and criminal mischief (La. R.S. 14:59(A)(5)) on October 30, 2019.
- 4. Ms. Nelson failed to disclose the arrest on her 2020 LMSW renewal application and her 2021 LCSW licensure application.

WHEREAS, by (1) failing to report the arrest to the Board within seven (7) business days of the arrest; (2) failing to report the arrest on her 2020 LMSW renewal application; and (3) failing to report the arrest on her 2021 LCSW licensure application, Ms. Nelson violated La. R.S. 37:2717(A)(3), and La. Admin. Code tit. 46:XXV §117(E).

WHEREAS, undersigned counsel has confirmed Ms. Nelson's desire to resolve this matter through a Consent Agreement and Order;

Initial:**[[5]** 4787090.v1 WHEREAS, Ms. Nelson agrees not to repeat the misconduct mentioned in this Consent Agreement and Order, and acknowledges that any further misconduct mentioned in this Consent Agreement and Order will be considered a violation of the terms of this Consent Agreement and Order and shall be cause for further disciplinary action;

WHEREAS, Ms. Nelson recognizes her right to have an administrative adjudication of the charges outlined in the complaint and notice letter, at which time Ms. Nelson would be entitled to be represented by legal counsel, to call witnesses, and to present witnesses on her behalf in defense or in mitigation of the charges made, and to a decision thereon by the Board based upon written findings of fact and conclusions of law in accordance with the Louisiana Administrative Procedure Act. Ms. Nelson nonetheless waives her right to formal adjudication and, pursuant to La. R.S. 49:975(D), consents to the entry of the Consent Agreement and Order set forth hereinafter. Ms. Nelson also acknowledges that she waives any rights to which she may be entitled pursuant to the Louisiana Administrative Procedure Act, La. R.S. 49:951, et seq., or which she otherwise may be afforded by any law, to contest her agreement to, or the force and effect of this Consent Agreement and Order, in any Court or other forum.

IT IS HEREBY ORDERED that in consideration of the foregoing and pursuant to the authority vested in the Board by La. R.S. 49:975(D), the Board orders and Ms. Nelson accepts the following administrative action which is a final decision pursuant to La. R.S. 49:977:

1. The LMSW license of Jasmine Nelson to be engaged in the practice of social work in the State of Louisiana, as evidenced by license number 13208 shall be, and is hereby SUSPENDED for one (1) year from the date the parties sign this Consent Agreement and Order. The Board must approve Ms. Nelson to return to practice following the suspension period and her compliance with the terms of this

Agreement. Accordingly, Ms. Nelson accepts and shall maintain strict compliance with the following terms and conditions.

- 2. Following the Board's approval to terminate the suspension period described above, Ms. Nelson's license will be placed on PROBATION for a period of two (2) years from the date the suspension period is terminated.
- 3. Upon the return to social work practice, Ms. Nelson must be supervised by a Board-Approved Clinical Supervisor ("BACS") one (1) time per month for one (1) hour for a period of two (2) years.
- 4. Ms. Nelson shall pass the Board's Open Book Examination on the Social Work Practice Act and Rules, Standards & Procedures within three (3) months after the date the parties sign this Consent Agreement and Order.
- 5. Ms. Nelson shall complete a total of three (3) hours of continuing education on the subject of ethics. These hours are to be pre-approved by the Board prior to completion. These continuing education hours must be completed in addition to all standard renewal requirements for her LCSW licensure. Ms. Nelson shall provide the Board with evidence of attendance within twelve (12) months after all parties sign this Consent Agreement and Order.
- 6. Ms. Nelson shall pay a fine in the amount of ONE THOUSAND TWO HUNDRED AND FIFTY DOLLARS AND 00/100 (\$1,250.00) within one (1) year from the date all parties sign this Consent Agreement and Order. The payments shall be made on a quarterly basis with the first payment due within ninety (90) days from the date all parties sign this Consent Agreement and Order. Payment shall be made by credit card, certified check, or money order.

- 7. Ms. Nelson shall pay costs associated with Complaint No. 2022-09 in the amount of \$1,000.00 within twelve (12) months after the date all parties sign this Consent Agreement and Order. The payments shall be made on a quarterly basis with the first payment due within ninety (90) days from the date all parties sign this Consent Agreement and Order. The payments shall be made by credit card, certified check, or money order.
- 8. Ms. Nelson further acknowledges that failure to reimburse the fees set forth above at Paragraphs 6 and 7 will require the Board to take further action in collection of this debt. Respondent has twelve (12) months to reimburse the expenses before the debt will be considered final and transferred to the Louisiana Office of Debt Recovery (ODR). After transfer, the debt is subject to an additional collection fee of up to twenty-five percent (25%) of the total debt liability, as provided for in LA R.S. 47:1676 (E).
- 9. Ms. Nelson specifically acknowledges that failure to comply with the terms of this Consent Agreement and Order may result in a denial, revocation, or suspension of any license, certificate, or registration issued by, or applied for, in accordance with La. R.S. 37:2717.
- 10. Ms. Nelson shall report the terms of this Consent Agreement and Order to any board or agency with which she is licensed or registered.
- 11. By agreeing to the terms of this Consent Agreement and Order, Ms. Nelson waives all rights to appeal this adjudication.

Effect of Non-Acceptance of Agreement. Ms. Nelson acknowledges that this Consent Agreement and Order is subject to the approval of the Board. She further acknowledges and agrees

Complaint may be filed relative to the allegations contained herein. If this Consent Agreement and Order is rejected by the Board, it will not constitute a waiver of Ms. Nelson's right to a hearing on the matters alleged in an Administrative Complaint and the admissions contained herein will have no effect. She further agrees that if the Board rejects this Consent Agreement and Order, the members of the Board may decide the matter after a hearing, and their consideration of this

Consent Agreement and Order shall not alone be grounds for recusal of any member of the Board,

including any claims that the Board is biased against her, that it cannot fairly decide the case, or

that it has received ex parte communication.

IT IS HEREBY FURTHER ORDERED that this Consent Agreement and Order shall take effect immediately upon its adoption by the Board and is a public record of the Board. The terms of this Consent Agreement and Order may be published and reported in, including but not limited to, the LABSWE Newsletter, the Association of Social Work Boards (ASWB), and the National Practitioner Data Bank-Healthcare Integrity and Protection Data Bank (NPDB-HIPDB).

The prosecutor acknowledges negotiation and preparation of this Consent Agreement and Order in order to resolve, with prejudice, all matters for which the social worker could be charged under Complaint 2022-09, and further certifies that this Consent Agreement and Order is consistent with the evidence, adequately addresses the complaint, and represents a true and correct statement of that which could be proven at a hearing of this matter.

I expressly acknowledge that the disclosure of such information to the LABSWE shall be without prejudice to the Prosecutor's authority to file a formal Administrative Complaint, or the LABSWE's capacity to adjudicate such Administrative Complaint, should the LABSWE decline to approve this Consent Agreement and Order. I further acknowledge my awareness that should the LABSWE approve this Consent Agreement and Order that the Consent Agreement and Order will become a matter of public record.
